104.3 WZYP'S "VETERAN FREE TIRE GIVEAWAY" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WZYP ("Station"), 806 Governor's Drive, Suite 101, Huntsville, AL 35801, during available business hours Monday through Friday, on the Station website at www.wzyp.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the WZYP "Win Your Own Private Movie Screening at Madison Square 12" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
 - Eligibility. This Contest is open only to legal U.S. residents, excluding Florida and New York residents, age nineteen (19) years or older at the time of entry with a valid Social Security number and who reside in the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, who have not won a prize from the Station in the last (30) days or a prize valued at \$500 or more in the (30) days, and whose immediate family members or household members have not won a prize from the Station in the last (30) days or a prize valued at \$500 or more in the (30) days Void where prohibited by law. The term "immediate family members" includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. - 2. Contest Period. The Contest will begin at 6:00am CT on Monday, October 12, 2020 and run from 6:00am CT until 5:00pm CT each weekday through Friday, November 6, 2020 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.** To enter:
 - Listen to the Station weekdays from 6:00am CT to 5:00pm CT during the Contest Period. When the Station plays the "cue-to-call" sounder, listeners must call the Station at (866) 476-1043. Caller 10 to the Station, as determined by the Station in its sole discretion (each, a "Qualifier"), will win a Qualifying Prize and be eligible for a chance to win a Grand Prize. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.
- 4. **Winner Selection.** Each Qualifying Winner will be selected as set forth above.
- 5. On or around 6:00pm CT each Friday during the Contest Period (each, a "Selection Day"), Station will select one (1) entry in a random drawing from among all Qualifiers identified through that Selection Day. The winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with

the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification and forfeiture of the prize.

- Verification of Potential Winner, THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS 6. IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BIN DING IN ALL MATTERS RELATED TO THE CONTEST. Each potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) in order to claim his/her prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind such winner's acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize.  - (b) Four (4) Grand Prizes (one for each of the four Selection Days through the Contest Period) will be awarded in this Contest. Each Grand Prize winner will receive: a private movie screening for twenty people (winner and 19 guests) at Madison Square Luxury Cinemas, located at 5905 University Drive, Huntsville, AL 35806, on a date and time and movie as determined by Station and Madison Square Luxury Cinemas. The ARV of the Grand Prize is: One Hundred Fifty Dollars (\$150).

THE TOTAL ARV OF ALL CONTEST PRIZES IS: ONE THOUSAND DOLLARS (\$1,000).

Other restrictions may apply.
- 8. **Entry Conditions and Release.** By entering, each entrant agrees to: (a) comply with and be bound by these Official Rules and the decisions of the Station, which are binding and final in all matters relating to this Contest; (b) release and hold harmless Station, Cumulus Broadcasting LLC, Cumulus Media New Holdings, Inc., and each of their subsidiaries, related and affiliated companies, participating sponsors, the prize suppliers and any other organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the Contest, and each of their respective past and present officers, directors, employees, agents and representatives (collectively, the "Released Parties") from and against any and all

Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Station in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the state in which the Station is located, without giving effect to any choice of law or conflict of law rules (whether of the state in which the Station is located or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the state in which the Station is located.
